INTRODUCTION

Vijaya College of Nursing is functioning under Vijaya Educational Trust of India, established in the year 2005 and is attached to Vijaya Hospital, which is a 300 bedded Super specialty Hospital. The College campus is situated 2 kilometers away from Kottarakara town in Kollam District.Kerala

Overview of the B.Sc. Nursing Course

- This college offers 4 Years B.Sc. Nursing Degree Course as affiliated to Kerala University of Health Sciences, (KUHS), approved by the Indian Nursing Council & Kerala Nurses and Midwives Council.
- Admission process of this college is through our college website. Application form can be downloaded either online or can be collected from college office directly by paying Rs. 750/-.
- This prospectus contains the rules and regulations for selection and admission to the course to be filled by Management of Vijaya College of Nursing for the academic year 2024-2025
- This prospectus is subject to modification/addition/deletion as may be deemed necessary by the college and subject to the instructions of Kerala University of Health Sciences and Government of Kerala

II. NUMBERS OF SEATS

The annual intake for B.Sc. nursing is 70.**All the candidates** admitted shall pay the fees fixed by Government of Kerala / Fee Regulatory Committee and as approved or modified by competent authorities.

III. ELIGIBILITY FOR ADMISSION

Academic :

(i) Candidates who have passed Higher Secondary Examination of the Board of Higher Secondary Examinations, Kerala or equivalent examinations recognized by any of the Universities in the State of Kerala with Aggregate of 50 % marks in Physics, Chemistry, Biology and 50 % marks in English in second year (Plus two), only are eligible for admission.

(ii) Relaxation in marks:

- a. Candidates belonging to SEBC (Socially and Educationally Backward Classes) in the State of Kerala with total annual family income below Rs.6 lakhs will get relaxation of 5% marks. The Scheduled Caste and Scheduled Tribe candidates in the state of Kerala need only a pass in the qualifying Examination.
- b. Those candidates claiming relaxation of marks shall produce necessary certificates from the authority concerned.

There will be no reservation of seats for SEBC and or SC/ST candidates under Management quota.

Eligibility Certificates: Candidates who have passed their qualifying examination from places other than the State of Kerala shall produce the certificate of recognition and equivalency of qualifying examination from KUHS, Thrissur. This should be furnished at the time of interview for admission.

Age:

- 1. Applicants should have completed 17 years of age on 31st December 2024. No relaxation of the minimum age will be allowed.
- 2. Self attested copy of relevant page of school record namely SSLC/ICSE/CBSE/ certificate showing the date of birth / copy of birth certificate should be produced at the time of admission.

IV. HOW TO APPLY

Application for admission to B.Sc. Nursing course can be registered online through a single application. The provision for applying online is available at the website <u>www.vijayacollegeofnursing.org</u>. Submission of more than one application by a candidate will lead to rejection of the applications for the same course submitted subsequent to the first application. Incomplete application, false information will also lead to rejection.

Application Fee:

- 1. The application fee will be Rs 750/-. The payment can be done directly in Vijaya College of Nursing office or via online. Submission of application will be considered only after uploading scanned copy of Fees receipt.
- 2. Application fee once remitted will not be refunded at any circumstances.
- 3. Only paid applications will be considered for admission.

Availability of Prospectus

Prospects can be downloaded from <u>www.vijayacollegeofnursing.org.</u>OR can be collected from the College of Nursing.

Remittance of Application Fee and Submission of Application Form

- There will be three stages for the submission of an application form and all stages are mandatory.
- Candidates should complete all the stages of application submission as per the time schedule which is notified through the website/media.

Stage 1- Entering candidate details in Online.

Stage 2- Online payment of application fee by uploading scanned copy of fees paid receipt.

Stage 3- Submission of completed filled in application form.

Direct Submission of application form in the college office:

Fill the application form and submit to the nursing college office with requisite documents. The candidate can also submit application through online and upload fees paid receipt.

Remittance of Application Fee and Submission of Application

- 1. Candidate shall visit official website <u>www.vijayacollegeofnursing.org</u> and Click the link "Apply now"
- 2. The personal details of the candidate to be filled in the concerned page and click save button.
- 3. Enter details of qualifying examination.
- 4. Upload documents mentioned in application form.
- 5. Upload fee receipt.
- 6. Click **SUBMIT NOW** button for Final Confirmation.

V . PREPARATION OF MERIT LIST

Merit list:

- a. Out of 50% management seats 35% seats will be filled up by management from among the applications received by the college on the basis of merit list prepared based on the marks obtained in the qualifying examination in the core subjects as mentioned in the eligibility criteria.
- b. Out of 50% management seats 15% NRI seats will be filled up from qualified students as per G.O (Ms) No.243/2014/H&FWD dated 6.08.2014 of Govt. of Kerala. The original documents and Certificate should be submitted at the time of admission.

Documents for NRI Candidates

- 1. Sponsorship Certificate
- 2. An affidavit for NRI sponsorship by the NRI relative.
- 3. Attested copy of the passport of the sponsor
- 4. The attested copy of the relevant page of the passport where Employment Visa is stamped and employment certificate duly attested by the Indian Embassy or consulate.
- 5. *Relationship Certificate from the Village Officer/Tahasildar.
 *Relationship with the sponsor should comply the Government order GO(Ms) No.193/2013/H&FWD dtd.22.05.2013& KUHS Order No.2836/ACB/Kuhs/2014, dated 12.06.2014

Resolution of tie while ranking:

In the case of a tie in the total marks, the marks in Biology will be counted. If there is still a tie the marks in Chemistry and Physics will be counted. If a tie still exists, the age of the candidate will be taken in into account, the elder will be given preference to the younger.

Validity of the merit list:

- The published merit list will be valid till the date up to which the merit list shall be kept alive in terms of instruction/direction of competent authority.
- Inclusion in the merit list will not entitled, unless the applicant satisfies the rules regarding the eligibility for admission and other conditions as laid down in the Prospectus.
- Furnishing of false information/particulars would result in the forfeiture of the candidate as well as cancellation of admission to the course, and in addition, will attract the relevant provisions of criminal law of the land.

VI . SELECTION OF THE CANDIDATES

Selection of the candidates is only on the basis of the rank lists prepared and published in the website based on the marks secured by the candidate in the qualifying examination.

VII. ADMISSION & PAYMENT OF FEES

- The selected candidates will be informed about the date and time of admission through the website.
- The students shall pay all fees of the 1st year of the course at the time of admission which will not be refunded at any circumstances.

VIII . SPECIAL INSTRUCTIONS

- **1. Ragging:** Ragging in any form is strictly prohibited in college. College is committed to abolish ragging in the campus.
